

## May 20, 2022 SacMoves Notes

1. Welcome and Introductions (10 mins) (All); Anne Stausboll facilitated in Steve's absence, with Dan Allison as co-host, and Tess Townsend graciously volunteered to take notes
2. Updates (20 mins):
  - a. Sacramento City Council climate plan, budget and transportation follow-up (Anne Stausboll)
    - i. Had hoped for local match from city for the "seven big idea" transportation projects, but there is no local match—despite ideas coming from the city staff, and projects have not been scoped because of insufficient staffing
    - ii. Also seeking additional staff to develop and implement Climate Action Plan (CAP), currently 18 months late
    - iii. 2 more meetings: May 31 budget discussion, June 14 budget approval
    - iv. May 25 lunch & learn to include info on where they are on funding green transportation projects
  - b. Sacramento County Climate Action Plan (Susan Herre/Ralph Propper)
    - i. County has to prove it has available land and that it is properly zoned for housing needs
    - ii. CAP emergency task force has issued call for applications
    - iii. ECOS, 350, another group are in communication with same law firm as sued San Diego over its insufficient CAP
  - c. SacMoves Process Committee (Dan Allison)
    - i. Has not met since the last SacMoves meeting.. Working on scheduling meeting. Will probably prioritize work on updating charter.
3. SacMoves Web Presence (Dan Allison) -
  - i. Dan - It would be a blog - [sacmoves.wordpress.org](http://sacmoves.wordpress.org) - home page would be mission, no logo or design elements; documents page with links to letters SacMoves has sent
  - ii. Sue Teranishi: Will it have a contact form?
    1. Dan Allison: There is an ability to make a contact form but no central person designated to respond to inquiries
  - iii. Consensus that Dan will proceed to develop the web page, and will present it at the June SacMoves meeting for approval to go live.
  - iv. Input included desire for a contact person to be included, and for discussion of protocols.
4. Transportation measure
  - i. Sacog analysis: If the transportation measure gets approved, likely Sac Area would be 2% off of GHG reduction goals, and that could jeopardize competitiveness of region for state and federal grants
    1. Mayor is negotiating with Transportation supporters and SACOG; negotiations are near completion
    2. Outline of proposed terms from mayor: Mitigation plan would be required for support, sacog has to provide guidance for mitigation, additional \$300 million to be set aside to use for mitigation for the connector and the \$300 million is not necessarily a cap so could be

more; \$100 million from measure would go to mobility center, would come from Sacramento City pool of funds that would otherwise go to other projects

- ii. Roger Dickinson: Steve & Roger met with Josh Wood (representing Transpo Measure proponents), who says he is trying to find a satisfactory approach for those who would be inclined to oppose the measure. Since the measure's language cannot be changed at this juncture, any new terms will be documented in a side agreement, raising questions of enforceability. Another issue is that it is not only the connector that impacts GHGs, but projects predicated on the connector. Are those accounted for in the 2%? Unlikely. "Still a number of questions out there"
- iii. Jeffery Tardaguila – has not heard enough evidence to change SacMoves position against the measure. "Too little too late"
- iv. Dan Allison – This agreement does not appear binding
- v. Ralph Propper – Barry Broome GSEC previously opposed to measure, so he is surprised to hear of the possible \$100M commitment to the Mobility Center as part of the negotiations
- vi. Barbara Stanton – This initiative rolls back allocated funding for Senior and Disabled Transportation Services (from 4.5% to 3% – this is in language from measure – compare that to current Measure A, which does not sunset until 2030)
- vii. Ralph Propper – Signature gatherers for measure were at Earth Day
- viii. Tess Townsend – Partner encountered someone collecting signatures who denied that there was a connector
