### **STA Hearing Thurs Dec 10, 2020**

Sacramento Transportation Authority Hearing Thurs Dec 10, 2020 - Decennial Review on Potential Amendments to the Measure A Expenditure Plan - Submitting Coalition letter by 12/4.

There is a hearing on Thursday, December 10<sup>th</sup>. If we want to submit comments and have them included in the staff report, we need to submit the Coalition letter by Friday, December 4<sup>th</sup>. Steve Cohn will draft the pages and submit it Friday morning.

The decennial review was supposed to take place this year, we tried to push it to 2021 to get Measure A on the ballot, but we were unable to. No one in the jurisdiction in the November hearing went for transportation. Bike safety was talked about more, we need to get more details on how that went. We will need to set up a subcommittee on how to follow this. We should remind them to set up a policy framework that we think is suitable and remind them that we are here. We should look at any changes that should be put into place for a new Measure A. A draft recommendation of the hearing will tentatively be out on February 11th.

We should push for active transportation. The county is going through an active transportation plan. They are doubling down on support and coming from a clean air standpoint. It is important to prioritize some of that. We also need to echo the equity piece. We want to reiterate where we stand and what we support.

There needs to be a 55% approval of transportation measures, but it has never been able to get out of the legislature. Other jurisdictions have been able to pass measures.

Steve Cohn spoke to Dan Levitt, Manager of Regional Initiatives at SJRRC and ACE Rail. He is trying to get a central valley sponsor.

The council will review strategies for the pending climate action plan at the December 1<sup>st</sup> meeting. The December 8<sup>th</sup> meeting will be a review of the findings of the internal audit of the internal sustainability's functions.

## Updates

- Sac City Implementation of Mayors Commission on Climate Change Final Report and Sac County climate action plan (Anne Stausboll, Emel Wadhwani, Ralph Propper)
  - They were willing to push the CAP along without really considering the recommendations that we had put in our letter in terms of what the Mayor had in his commission. At some point, we will want to weigh in again.
- Slow Streets (Deb Banks)
  - Trying to get some more money for this. We need to know from the city what the process is. We might need help from other council members, besides the Mayor, such as Katie Valenzuela and Mia Vang, and a lot more people on the council and engage them. We need to create a broader-base support. We can also include Angelique Ashby and the other new council member Sean Loloee. Steve Cohn has requested a meeting from him. Larry Grove is another new useful contact. Eric Guerra could be helpful as well.
- Regional Transit (Chris Flores/Glenda Marsh)
  - Glenda wants to get a meeting with the new Mayor of Elk Grove. The current Measure A has no funding, so grants are so supportive of RT. SMART found a fiscal agent in Valley Vision and will be under their 501 ©3 umbrella, which helps to open up some grant opportunities.
- Regional Rail (Alison MacLeod)
  - There was a great conversation with the city. Valley rail comes into the station North of RT tracks, East of Safeway where East and 19<sup>th</sup> Street is. Sac City College should be the RT connection. RT is working with the city, it has a fair amount of money to work with and has additional funds. The Elk Grove station has lagged because it has changed its location a number of times. Natomas is working with RT to have a shuttle to the airport.
